16.0 NEW BUSINESS:

a) Cemetery Boards: The Trustees met to discuss the amalgamation of the Cemetery Boards at Annesley, which had been recommended at the AGM held on February 2, 2020. A combined cemetery board would reduce unnecessary duplication of duties. Any finances belonging to the cemeteries would remain for their perpetual care. The Trustees made the proposal at the September 15, 2020 Board of Elders meeting. The Board passed MOTION#2020/21-16 to accept the recommendation, and are asking the congregation to approve the decision. As the Harkaway board is considering a transfer of ownership to The Township of Chatsworth, the merger would be between the Vandeleur and Irwin/Ebenezer Boards, with an option for Harkaway to join in the future.

MOTION#11 (Dale Armstrong/Dale Fawcett): that the Vandeleur and Irwin/Ebenezer cemetery boards be amalgamated as recommended by the Board of Trustees and the Board of Elders, with an option for Harkaway to join at a future date.

This amalgamation will occur on December 31, 2021.

MOTION CARRIED

b) Reopening: At the Board of Elders meeting of June 22, 2021, a target date of September 14th to reopen for in-building services was made. At this time, 25% capacity of the building is the rule. Attendees would not be able to sing, sit close together, or meet for coffee afterward. There are some people who say that due to the Delta Variant of COVID-19, they would be uncomfortable attending until they are assured that all had been vaccinated. Others would stay away until we are able to have services that have more social interaction. Others understand the desire to not want to come back until things can be more normal, but said that is not going to happen for a long time. They say that we need to get together-some people will still stay away, but those who want to experience a service again should be able to. A show of hands showed that most attendees at the meeting would return to in house services if they were held. The Baptist Church have been open for services most of COVID, but have live streamed their services, and also have a ZOOM phone service for people without internet.

The Netcast ministry as it was done for 1.5 years has been discontinued. It was a lot of work to record and edit the services, and was exhausting for all involved. It was time to do things another way, because if we had in-building services, there would be too many wires and equipment in the

way, plus people would not want to sit through a recording that took several hours. It would be a travesty not to continue to reach out to the hundreds of people who won't be able to attend services. So, live streamed services are the answer - people who want to attend can be there for the service, but those who cannot attend can watch from home. A copy can be posted to the website and YouTube channels for viewing after the live stream.

Equipment from CTRD services in Owen Sound would cost \$15,000, plus \$3,000 or so for training and wiring setup. This company did the broadcasting for Farmer's week, and it was very well done. We are investigating the cost of putting together equipment that will do the same job at a lower cost. The equipment would be a capital cost, so the Investment Fund could be used for its purchase, and technology grants are available through the United Church of Canada. It was agreed to carry forward and obtain equipment to live stream and record the services to reach all people.

Pulpit supply and musicians will be needed for the services.

BOARD OF TRUSTEES

The members of the 2021 Board of Trustees were: David Armstrong, Mona Livingstone, Gail McCauley, Brian McKillop and Ray Robertson. Mona moved to London during the year, so retired from the Board of Trustees. We recognize and give thanks to Mona, Mora Foster and Mel Chamberlain for their long time service on the Board of Trustees.

At the Annual Meeting of the Congregation, held on July 14, there was vote based on the Trustees' recommendation to combine the cemetery boards on December 31, 2021. The Trustees proposed and recommended the amalgamation of the Vandeleur Cemetery Board with the Irwin - Ebenezer Cemetery Boards, leaving the option for the Harkaway Cemetery Board to join in the future. This proposal was shared with and supported by the Board of Elders at their Meeting on September 15, 2020. This recommendation came from the previous AGM, where it was suggested that the combination of the boards would remove duplication of board administration, and streamline the volunteer process.

Our Insurance Broker continues to be Nicol Insurance in Owen Sound. Our insurance will continue to be with Marsh Canada Limited (Marsh) for this coming year. The Trustees arrange the renewal of the property insurance each year on March 1st. In 2021, the deductible amount was increased to \$10,000 to lower the insurance premium paid by Annesley. Marsh also provides third party liability insurance coverage to users of our church facilities who currently do not carry liability insurance.

MINISTRY AND PERSONNEL COMMITTEE

Another COVID year and our report again this year is short. Because of COVID-19 restrictions, our committee met only once in person. Committee member Mark Worthington has done a wonderful job of keeping in touch personally with staff members Patti Shaw, Marlene Ward and Vivien Tolton. We are so grateful for their dedication and hard work during these most challenging times. We are also grateful to the huge number of volunteers who have stepped forward this past year to take up roles that are traditionally those of paid ministry staff. It's because of these folks that we have been able to enjoy weekly worship services.

We would also like to recognize the work of Rev. Kathy Underwood who has helped our congregation navigate these strange times. Her support for the life of this church has been truly immeasurable.

CHURCH LIBRARY REPORT 2021

Over this challenging year, the library acquired 15 new books and had 12 sign outs. New books were in the category of prayer, parenting, addiction, personal exploration, social awareness and grief. Regular notices in the weekly bulletin and on the website kept readers aware and generated loans in spite of the restrictions on church attendance. Distribution was via 'shank's mare' or our irreplaceable secretary Patti, in conjunction with her delivery of bulletins.

What *is* the value of this library? It is not quantitative, being a resource that supports a small number within the congregation, often at a critical time in their lives. During this time without a minister, often an intelligent book will anchor a person who is struggling. Keeping it accessible is difficult during these restrictive times. However, our shelves are full of wonderful material. The plan for 2022 is to do a complete inventory. With that in place, accessibility of the material will be easier.

VISIONING COMMITTEE UPDATE

The Annesley U C Visioning Committee has now had 5 productive meetings in which we have been developing some possible directions for the church to work toward. Most of our work to date has been around the future of the church building itself, since there are more potential opportunities available to us.

Ministry has continued to be a challenge; however, there have been some discussions with other places of faith about potential partnerships which have included, shared ministry, staff, space, and the possibility of streaming services between churches or churches could each contribute a portion of a whole service. To date, we have had responses from Meaford and Georgian Shores. Both churches have expressed some interest in working with Annesley, although further discussions would be needed. We have had one exploratory meeting with Meaford. They are interested in a possible shared ministry (50%) including pastoral care support. In recent years they have invested a considerable amount of money to maintain the church building which they plan to keep. Respective Community of Faith and Financial Records are in the process of being shared. A small delegation from Meaford attended Annesley on Feb. 3rd to consult with our Technical Ministry Team around improving their streaming capabilities. We had an additional meeting with Meaford on Feb.16th for further discussion and to help us get to know each other better. The Visioning Committee will continue to reach out and/or wait for responses from other faith groups.

Pulpit Supply is filled for every Sunday through the end of April.

For the church, we have met with a variety of outside agencies for potential partnerships:

- Community Hub We have had discussions with a Toronto based theater/dance company. This organization has been very helpful in providing ideas for a potential Community Arts Hub. We have consulted and plan to visit a similar arrangement at St. Joseph's Kingsbridge Community Centre near Goderich. There has also been discussion around informing the community of Markdale/Grey Highlands about concerns for the future of Annesley United Church.
- 2. UPRC Meetings were held with the United Church Property Resource Corporation. This group works to repurpose sections of churches for potential affordable residential opportunities. They have determined that a development at our location is not feasible due to space restrictions.

- 3. Daycare We had a meeting with George Prentice of First United in Owen Sound. He was involved in the development and operation of a daycare in their church, and now rent out to Queen of Hearts Daycare. The proprietor of Queen of Hearts expressed interest and provided an introductory proposal for partnership. The Queen of Hearts daycare owner has visited Annesley, but indicated that the creation of a daycare in the basement would not be feasible due to building issues (windows, washrooms, and kitchen). There continues to be a possibility of a daycare that is not housed in the basement.
- 4. On Feb. 6th the Visioning Committee had an exciting meeting with architect, Lloyd Hunt. It was encouraging that he had many similar thoughts about ways the church can be used. Lloyd recognized the potential that the building has, considering the expected population growth in the area and the facilities that Annesley already has. The sanctuary is very well suited to concerts considering the 4 easy exits and the compartmentalization of the building make it adaptable. A Life Safety Study would be easily secured.

We have enjoyed working with each other, and continue to be excited about the possibilities for Annesley United Church. CEMETERIES

At the Annual General Meeting in 2020, the Trustees were directed to meet to discuss the amalgamation of the Harkaway, Irwin-Ebenezer and Vandeleur Cemetery Boards. At the September 15, 2020 meeting of the Annesley Board, the Trustees presented a document recommending a combined cemetery board, to reduce unnecessary duplication of duties. Each board has historically been composed of cemetery neighbours or descendants, and there is concern about who will take over the duties in the future. A combined board would open the volunteer pool to a wider range of participants. A new board would consist of new and old members from all communities to manage the finances, fundraising and maintenance. Any finances belonging to each cemetery would remain for their perpetual care. The board passed MOTION# 2020/21-16 to merge the boards. This recommendation was brought to the 2021 Annual Congregational meeting on July 14, 2021. **Motion #11** was passed to combine the Irwin -Ebenezer and Vandeleur boards on December 31, 2021, with Harkaway invited to join. The Harkaway Board decided before December 31, 2021 to join in the amalgamation, *so all boards were combined on December 31*, 2021.

These cemeteries as well as being the resting place for ancestors of our community are also sources of historical information for those tracing family history. The Board encourages those interested in preserving these historical sites to make their donations through Annesley United Church, indicating their intention on their envelope.

The Ebenezer Cemetery is located East of Markdale on County Road 30 at the site of the former Ebenezer United Church.

The Irwin Cemetery is located south of Markdale on Highway 10 at the site of the former Irwin Methodist Church. Both Cemeteries have been inactive for several years. Irwin-Ebenezer Cemetery Board Members: *David Armstrong* and *Ronald Wyvill*.

The Harkaway Cemetery is located at 635762 Euphrasia Holland Townline. The Harkaway board members: *John Lewis, Hillis Halbert, Jim Hawken, Blair Thompson and Janie Hanna*.

The Vandeleur Pioneer Cemetery is located at 154264 Grey Road 32.

Vandeleur Cemetery board members: *Bob Bowles, Jack Davis, Marilyn Davis, Dale Fawcett, Isabel Jeffery, Brenda Teeter.*

Financial reports for the Vandeleur and Harkaway Cemeteries will be provided at the Annual Meeting, as they were unavailable at the time of printing.

FINANCE REPORT FOR YEAR ENDING DECEMBER 31, 2021

The Operating Receipts for 2021 exceeded Expenses by \$8,110.61. Our Givings were \$9667 less than 2020. Our fundraising was just \$477 less than 2020. Expenses for building maintenance were lower than in the previous year. The surplus this year was due to drastically reduced wages expenses (no minister or Director of Music after April).

Preparation of the Budget for 2022 was again difficult and uncertain. It is more like a Financial Forecast. It is sound finance to be able to pay our Heat, Hydro, Insurance, Maintenance and Salaries with Givings, and not rely on Fundraising to pay those bills.

We are thankful for the work of the Lay Worship Team, who kept our paid ministry costs low, and the Visioning team, which is looking at ways that our building can generate more income.

The Annesley Congregation is an incredibly strong and resilient group. We have weathered the challenges in the past and will undoubtedly continue in our support of each other our families and the community in 2022.
